IF CAN IS LOST, STOLEN OR DAMAGED IN ANY WAY, THE UNDERSIGNED WILL BE BILLED FOR THE COST OF THE GARBAGE CAN. GARBAGE CANS MUST BE RETURNED TO THE COURTHOUSE IF THE UNDERSIGNED RELOCATES OUTSIDE OF GENEVA COUNTY.**

**IF YOUR ACCOUNT IS 90 DAYS PAST DUE, THIS IS CONSIDERED FAILURE TO COMPLY WITH THE SOLID WASTE COLLECTION AND DISPOSAL LAW AND WILL NECESSITATE LEGAL ACTION AS PROVIDED BY THE LAW, INCLUDING CHARGING THE PERSON IN VIOLATION WITH A CRIMINAL MISDEMEANOR.**

The Alabama Law (**AL Code 22-27-1, et seq.**) that establishes mandatory services and participation in the collection of solid waste or garbage by Geneva County, provides that every person, household, business, industry or property owner is liable for the monthly or annual fee for the solid waste or garbage collection services made available.

**AGREEMENT TO PAY:** The undersigned accepts the fee charged as a lawful debt and promises to pay said fee including the cost of collection, reasonable attorney fees, and court costs if such be necessary, waiving now and forever the right to claim exemption under the constitution and laws of the State of Alabama, or any other state.

**TO: GENEVA COUNTY RESIDENTIAL CUSTOMERS**

**RE:      GARBAGE COLLECTION**

**The following is information you need to know in reference to your garbage collection:**

1. ALWAYS HAVE CONTAINER TO ROAD SIDE NO LATER THAN 6:00 A.M. THE MORNING OF YOUR PICK-UP.
2. YOUR CONTAINER HAS TO BE **3 TO 5 FEET** FROM THE MAIN ROAD SIDE.
3. ONLY GENEVA COUNTY CONTAINERS WILL BE DUMPED. NO EXTRA CONTAINERS OR BAGS OF GARBAGE BESIDE THE CONTAINER WILL BE COLLECTED.
4. ONLY HOUSEHOLD GARBAGE WILL BE COLLECTED. NO TIRES, BATTERIES, FURNITURE, HAZARDOUS MATERIAL, WOOD, BRICK, CONCRETE, YARD WASTE. **ALL SYRINGES NEED TO BE PROPERLY BAGGED AND NOT THROWN IN CAN LOOSE, ETC.**
5. Geneva County will observe the following holidays: New Year's Day; Martin Luther King, Jr.; Memorial Day; 4<sup>th</sup> of July; Labor Day; Veterans' Day; Thanksgiving; & Christmas. **IF YOUR SCHEDULED GARBAGE PICK-UP FALLS ON ONE OF THE HOLIDAYS LISTED, YOUR GARBAGE WILL BE PICKED UP ONE DAY LATER.**
6. WE WILL BILL MONTHLY-----**\$12.00**  
YOU MAY PAY BY THE QUARTER **\$36.00** OR BY THE YEAR **\$144.00**.

**PLEASE NOTIFY US OF ANY CHANGE IN YOUR BILLING ADDRESS, PHONE #, ETC.**

7. IT IS VERY IMPORTANT THAT YOU NOTIFY US WHEN YOU PLAN TO MOVE, SO WE CAN DISCONTINUE SERVICE, & **STOP BILLING. IF YOU RELOCATE OUTSIDE OF GENEVA, YOU WILL NEED TO BRING YOUR CAN BACK TO THE GENEVA COUNTY COURTHOUSE.**

**If your account is 90 days past due, this is FAILURE TO COMPLY with the Solid Waste Collection and Disposal Law, and will necessitate legal action as provided by the law, including charging the person in violation with a criminal misdemeanor.**
